

SOUL FACILITATOR TRAINING COURSE

Accredited by AIPO - Italian Association of Holistic Practitioners

ADMINISTRATIVE DOCUMENT

The *Soul Facilitator* Training Programme is made up of all of the Courses offered by the School. To meet different needs, the School is offering 3 different Student Categories:

Student	Attendance Modality	Crescita Personale (Personal Development)	Professional Qualification
Type 1	3-year Regular Attendance	Yes	Yes
Type 2	5-year Flexible Attendance	Yes	Yes
Type 3	Flexible Attendance	Optional	No

- **Student Type 1**
Enrolled in the School with regular attendance in order to be professionally qualified as a *Soul Facilitator*.
- **Student Type 2**
Enrolled in the School with flexible attendance, according to their personal needs (a maximum period of 5 Academic Years), in order to be professionally qualified as a *Soul Facilitator*.
- **Student Type 3**
Enrolled in the School with flexible attendance, according to their personal time requirements. This Programme does not facilitate the possibility of being professionally qualified as a *Soul Facilitator* but, rather, offers an opportunity to obtain a qualification in one or more of the School Academic Subjects, defined as a Mini Pathway.

Tuition Fees

The Tuition Fees includes:

- **A) the Annual Enrolment Fee;**
- **B) the 3-Year Training Fee,** for Student Type 1 only;
- **C) Individual Training Course Fee,** for Student Type 2 and 3;
- **D) Crescita Personale (Personal Development) Activity Fees** (IIS Events, Sacred Tours, Master and Specialisation Courses, Supervisions, Tutoring, Homework, etc.), which are compulsory only for those who have the intention of becoming professionally qualified as a *Soul Facilitator*, and/or obtain a suitable qualification in one or more of the School Academic Subjects defined as the Mini Pathways.

A) Annual Enrolment Fee**Annual Enrolment Fee (Student Type 1, 2 and 3)**

The Annual Enrolment Fee for **Student Type 1, 2 and 3** is **€160,00 - VAT included**. This amount must be paid annually by 15th September.

B) Three-Year Tuition Fee (Student Type 1)

Student Type 1 must pay an Annual School Tuition Fee, which includes the participation in all the Academic Courses offered within the 3-Year Training Programme. The Crescita Personale (Personal Development) Activities, required in order to obtain the Professional Qualification as *Soul Facilitator*, and/or the qualification in one or more of the School Academic Subjects defined as the Mini Pathways, are excluded.

The Full 3-year Training Tuition Fee for Student Type 1 is € 15.000,00 - **VAT excluded**.

This Amount has been subdivided in 3 single year Academic fees of € 5.000,00 - **VAT excluded** – to be paid in two Annual Instalments, by bank transfer:

- The first Instalment, to be paid by 15th September of the Year of Enrolment;
- The second Instalment, to be paid by 31st March of the following year.

Suspension of the Training

Enrolment into the School, requires the Student to commit to the full payment of the Annual Fee by the agreed methods. This payment can only be suspended in the case of a *force majeure*, (extraordinary and unpredictable events not attributable to the Student's will) and, otherwise, is not entitled to any refund. The Student will not have the right, under any circumstance, to be refunded of the tuition fee already paid for the current Academic Year. The Courses which will not be attended during the specific Academic Year for reasons not attributable to the School, can be attended the following Academic Year, but no later.

C) Individual Training Course Fees (Student Type 2 and 3)

Student Type 2 and 3 must pay the tuition fee of the individual Course they wish to attend, before the beginning of the course, (according to the current Price List). For Student **Type 2 and 3**, a **15% discount** (approximately,) will be applied to the quoted price.

The course payment must be made by the following methods:

- A confirmation deposit at the time of booking, to be made **30 days before** the beginning of the course. This deposit **is not refundable**.
- Balance within **7 days before** the date of the course.

D) Crescita Personale (Personal Development) Activity (Specialization Courses, Master Courses, IIS Events, Sacred Tours, Individual/Group Supervisions and Tutoring) Tuition Fees.

The Crescita Personale Activities, which are compulsory only for those who have the intention of becoming professionally qualified as a *Soul Facilitator*, and/or obtain a suitable qualification in one or more of the School Academic Subjects, defined as the Mini Pathways, are listed in the School Structure Document. The cost of the above Activities is not included in the Annual School Fee (Student Type 1).



The Crescita Personale Activities include:

✓ **Specialization Courses, Master Courses, IIS Events, Sacred Tours**

They are specific Courses aiming at supporting a deeper inner work and the further development of specific topics taught during the Academic Year. The tuition fee of these seminars may vary from time to time, according to the specific course content.

✓ **Individual and/or Group Sessions:**

Tutoring: A *one-on-one* session, which provides for two kinds of support:

School Journey Tutoring, at the following cost for each individual session:

- **€120,00 - VAT included**, for **Student Type 1 and 2**;

- **€140,00 - VAT included**, for **Student Type 3**;

Personal Journey Tutoring, at the following cost for each individual session:

- **€135,00 - VAT included**, for **Student Type 1 and 2**;

- **€150,00 - VAT included**, for **Student Type 3**;

✓ **Supervision:** A process of facilitating and monitoring the Student's educational process. It can be carried out individually and/or in group, at the following prices:

Individual Supervision:

- **€35,00 - VAT included**, for a one-hour session;

Group Supervision:

- **From €100,00 to €150,00 - VAT included**, for a one-day class.

The payment for each session must be made at the time of booking.

Students enrolling in the School, must confirm they have read, understood, agreed and accepted the Terms and Conditions herein described.
